



Announcement of Mahidol University

Guidelines for the Use of Mahidol University Premises under the State of Emergency Announcement

Reference is made to the release of the Thai government's State of Emergency Announcement and the provisions under Section 9 of the Emergency Decree on Public Administration in Emergency Situation B.E. 2548 (No. 28) dated the 17th July 2021, Mahidol University would like to announce guidelines for staff operations, academic activities and other functions as follows:

1. Mahidol University will prohibit the use of the university premises in Phyathai, Bangkok Noi and Salaya Campus from the 20th July – the 2nd August 2021. All activities not relating to healthcare services or campus security and maintenance are not allowed during the period.
2. All heads of faculties/colleges/institutes in Phyathai, Bangkok Noi and Salaya Campus and vice presidents responsible for units and divisions in the Office of the President are to assign their staff to fully work from home. All staff members and students residing in or having to commute through the 13 highest maximum controlled areas especially in the Bangkok metropolitan area and its adjacent provinces close to Phyathai, Bangkok Noi and Salaya Campus, including Bangkok, Nonthaburi, Pathum Thani, Nakhon Pathom, Samut Prakarn, Samut Sakorn, Chachoengsao, Chonburi and Phra Nakhon Si Ayutthaya are advised not to travel at this time, except those in healthcare-related services, campus security and maintenance units. If necessary, staff members in other units are required a permission to be present on-site from the heads of faculties/colleges/institutes or vice presidents supervising units in the Office of the President, respectively.

3. All faculties/ colleges/ institutes in every campus are to follow Mahidol University's Guideline for Undergraduate Teaching and Learning (Academic Year 2564) dated the 23rd June 2021 and are advised to mainly organize academic activities online. If any faculties, colleges/institutes are to utilize the university premises for practicums or internship activities, a written memo is to be submitted directly to the President of Mahidol University.

4. All faculties/ colleges/ institutes in Phyathai, Bangkok Noi and Salaya campuses are to cancel activities leading to the spread of the COVID-19 and activities with participants more than 5 people, except those religious and traditional ceremonies. All measures relating to the prevention of the outbreak of the Coronavirus 2019 (COVID – 19) must also be strictly observed in all these events and ceremonies. Faculties/ colleges/ institutes in Phyathai, Bangkok Noi and Salaya campus planning to use the premises for activities with participants more than 5 people, a permission from their respective local authorities is required. Faculties/ colleges/ institutes in Salaya campus are to conduct an online self-assessment via the Thai Stop Covid+ in order to report to the Committee for Disease Control of Nakhon Pathom Province for consideration.

Please be advised accordingly. This announcement enters into effect from the 20th July 2021 onwards until further notice.
